RESOLUTION

On a motion by Supervisor Fleming
Seconded by Councilman Huestis

WHEREAS, after public hearing on August 5, 2014, the Town Board adopted a Local Law, subject to a mandatory referendum, to amend two Chapters of the Town Code and add a new Chapter to the Town Code regarding the Town Supervisor's term of office and the Town Councilman's term of office; and

WHEREAS, the Town Board wishes to provide the referendum proposition to the Putnam County Board of Elections for placement on the ballot for the general election of November 4, 2014.

NOW, THEREFORE, BE IT RESOLVED, as follows:

1. The Town Clerk is requested to forward the following question to the Putnam County Board of Elections for placement on the ballot of the general election of November 4, 2014.

PROPOSITION

Shall the office of Supervisor be limited to four (4) terms of two (2) years each?

Shall the office of Town Councilman be limited to two (2) terms of four (4) years each?

This Proposition shall cover the outcome of the biennial election of November 3, 2015.

BE IT FURTHER RESOLVED, that the Town Clerk is hereby directed to file the proposition with the Putnam County Board of Election.


